Ready-to-use, 2x concentrated Master Mix contains <i>TaqNovaHS</i> polymerase which is a mixture of recombinant <i>Taq</i> polymerase over-expressed in <i>E. coli</i> and a highly specific monoclonal anti- <i>Taq</i> antibody. The <i>TaqNovaHS</i> polymerase enables easy set-up of a hot-start PCR reaction at room temperature. The antibody binds reversibly to the enzyme, inhibiting polymerase activity at ambient temperatures, what prevents extension of non-specifically annealed primers and primer-dimers formed at low temperatures during PCR set-up. The antibody is released from the polymerase during initial DNA denaturation step, thus providing full DNA polymerase activity during standard cycling conditions.
